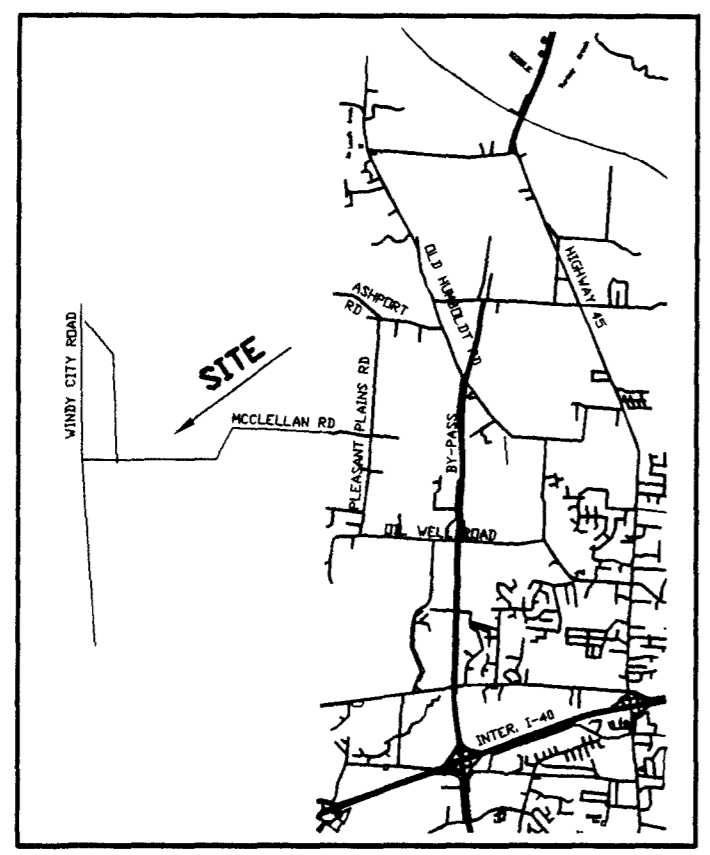


CENTERLINE CURVE DATA

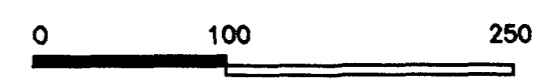
